SUBSCRIPTION TERMS

1. All subscriptions are payable to “Master Drawings Association, Inc.” Please mail to the address above.
2. Subscription is by volume only. Each volume includes four issues (nos. 1–4) and the annual printed Table of Contents and Index, which will be inserted (not bound) into the fourth issue.
3. Issues are published on a quarterly basis: March, June, September, and December.
4. Prepaid orders are required from all subscription agencies by year-end.
5. Receipt of your order after January 1st may result in delayed mailing of issues.
6. Late orders, received after January 1st, may be charged additional shipping for those issue already mailed.
7. Payment to be made preferably in the form of a check in US dollars drawn on a US bank or by International Postal Money Order. Bank fees may not be deducted from the cost of the subscription.
8. Payment may also be made by VISA or MASTERCARD. Be sure to include card number, date of expiry, and signature.
9. Bank wire transfers under \$300 are NOT accepted.
10. Be sure to include subscriber’s complete mailing details (and the subscriber number in the case of renewals) with each payment and all correspondence.
11. Mid-volume cancellations are not refundable.
12. Claims for replacement of defective or damaged issues, or issues lost in the post are accepted only for the four most recent issues, subject to availability.
